## **MEMORANDUM OF UNDERSTANDING**

**NECMETTIN ERBAKAN UNIVERSITESI TURKEY**

This Memorandum of Understanding is made on this 19<sup>th</sup> day of December 2016.

**BETWEEN**

**INSTITUT AGAMA ISLAM NEGERI (IAIN) MANADO**, an institution of higher learning established in Indonesia and having its registered office at Jl. Dr. S.H Sarundajang Kawasan Ring Road I Manado City North Sulawesi Indonesia and shall include its lawful representatives and permitted assigns;

**AND**

**NECMETTIN ERBAKAN ÜNİVERSİTESİ TURKEY**, an institution of higher learning established in the official journal numbered 27 648 and having its registered office at Yeni Şehir. Dr. Mehmet Hulusi Baybal Cd. No:12, 42060 Selçuklu/Konya, Turkey and shall include its lawful representatives and permitted assigns;

Institut Agama Islam Negeri (IAIN) Manado and Necmettin Erbakan Üniversitesi Turkey hereinafter referred to individually as "the Party" and collectively as "the Parties".

**WHEREAS**

- A. Institut Agama Islam Negeri (IAIN) Manado is an established university which strives to enhance and strengthen its research commitment to producing global leaders of tomorrow and has taken various initiatives to complement its educational excellence. In so doing, Institut Agama Islam Negeri (IAIN) Manado has entered into various collaborative arrangements with other parties to enhance the achievement of the said objectives.
- B. Necmettin Erbakan Üniversitesi, Turkey is an established university which intended to strengthen its academic and research excellence through various collaborations with other parties and institutions.
- C. The Parties are desirous of entering into this Memorandum of Understanding to declare their respective intentions and to establish a basis of co-operation and collaboration between the Parties upon the terms as contained herein.

HAVE REACHED AN UNDERSTANDING as follows:

## ARTICLE I

### OBJECTIVE

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations and national policies from time to time in force in each Party's country, will endeavor to strengthen, promote and develop co-operation between the Parties on the basis of equality and mutual benefit.

## ARTICLE 2

### AREAS OF CO-OPERATION

1. Each Party will, subject to the terms and conditions to be mutually agreed by both parties, further subject to the laws, rules, regulations and national policies from time to time in force, governing the subject matter in their respective countries, endeavor to act as a stimulus for a wide range of collaborative activities including but not restricted to:
  - (a) promotion of individual contacts among scholars, students and personnel of both scientific institutions;
  - (b) promotion and development of joint research, seminars, conferences, workshops, and also provision of assistance to each other in obtaining external funding from outside sources;
  - (c) provision of support to exchange of academic materials;
  - (d) co-operation in the area of Social Sciences, Humanities Studies, Islamic Studies and any other related field of studies;
  - (e) co-operation in areas of English language teaching for undergraduates and postgraduates;
  - (f) promotion of any other activities that both scientific institutions agree to be of mutual benefit; and
  - (g) any other areas of co-operation to be mutually agreed upon by the parties.
2. For the purpose of implementing the co-operation in respect of any area stated in paragraph 1, the Parties will enter into a legally binding agreement subject to terms and conditions as mutually agreed upon by the Parties including clauses on "protection of intellectual property rights, "confidentiality", "suspension", and "settlement of dispute".

**ARTICLE 3**

**FINANCIAL ARRANGEMENTS**

1. This Memorandum of Understanding will not give rise to any financial obligation by one Party to the other.
2. Each party will bear its own cost and expenses in relation to this Memorandum of Understanding.

**ARTICLE 4**

**EFFECT OF MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create, and is not intended to constitute or create obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

**ARTICLE 5**

**NO AGENCY**

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either Party as agent of the other.

**ARTICLE 6**

**ENTRY INTO EFFECT AND DURATION**

1. This Memorandum of Understanding will come into effect on the date of signing and will remain in effect for a period of 5 years.
2. This Memorandum of Understanding may be extended for a further period as may be agreed in writing by the Parties.

## ARTICLE 7

### NOTICES

Any communication under this Memorandum of Understanding will be in writing in the English language and delivered by registered mail to the address or sent to the electronic mail address or facsimile number of **Institut Agama Islam Negeri (IAIN Manado)** or **Necmettin Erbakan Universitesi**, as the case may be, shown below or to such other address or electronic mail address or facsimile number as either Party may have notified the sender and shall, unless otherwise provided herein, be deemed to be duly given or made when delivered to the recipient at such address or electronic mail address or facsimile number which is duly acknowledged:


